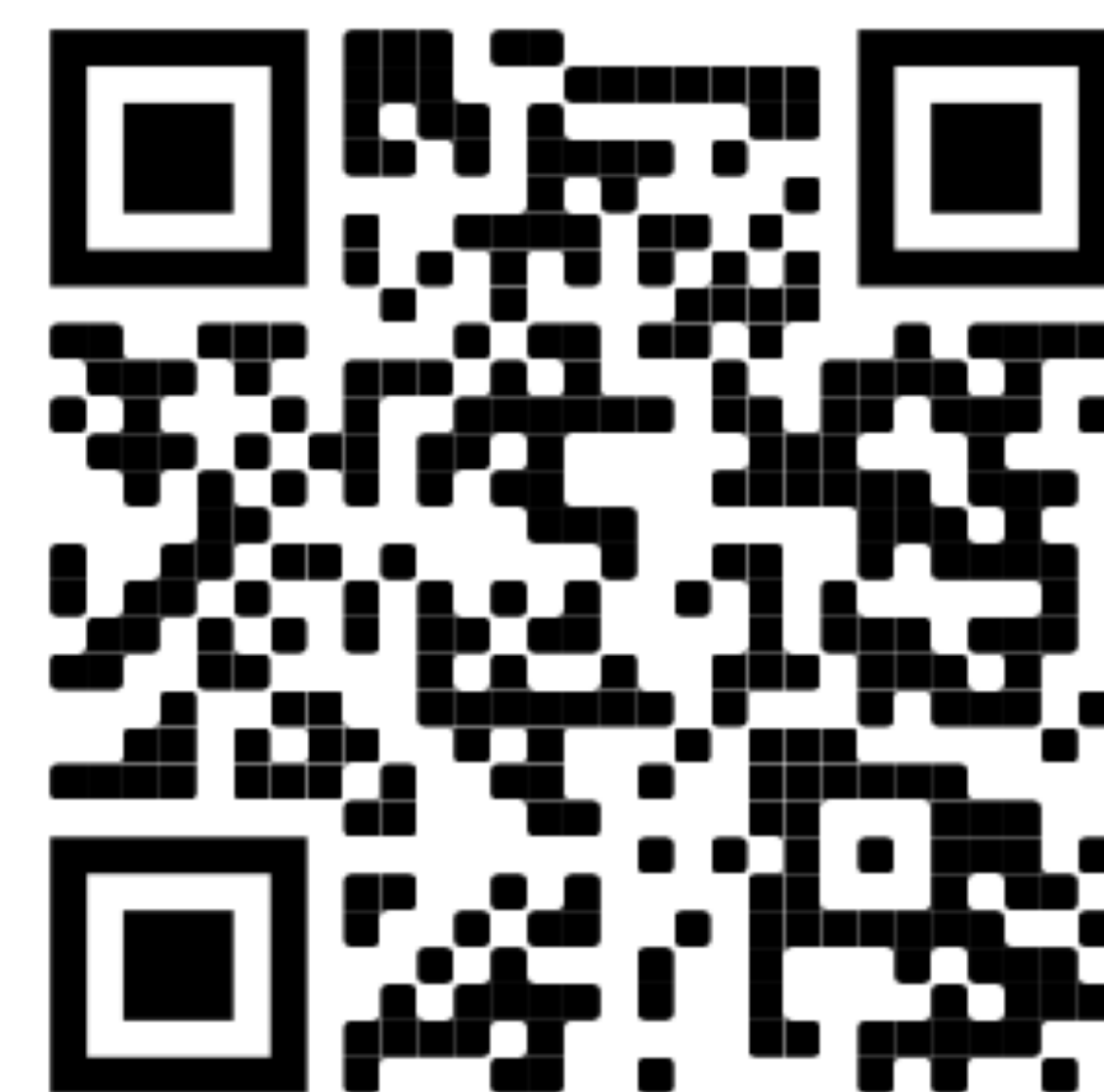
## Objective
