- Explain the role of documented cleaning schedules in maintaining compliance with regulatory and institutional protocols.
- Recognize potential sources of contamination resulting from improper cleaning techniques or product misuse.
- Review a real-world contamination case example to enhance cleanroom practices and ensure the safety of patients and staff.

#### **Addressing Sexual Health in Cancer Care**
